### Pulpit Supply Fees

Pulpit Supply Fees are \$100 per Sunday per service and that mileage be paid at the IRS business rate (currently \$.545/mile).

The Pulpit Supply List is for the convenience of sessions seeking occasional pulpit supply only.

If needed more than two consecutive Sundays, the Session must consult with their Committee on Ministry Representative.

### Moderator Fees

Session Moderator Fees are \$100 per quarter if the Session meets once per quarter, and that mileage be paid at the IRS business rate (currently \$.545/mile).

Session Moderator Fees are \$50.00 per meeting if a Session meets more than once a quarter and that mileage be paid at the IRS business rate (currently \$.545/mile).

The Moderator Fee for an annual or congregational meeting is \$50.00 and that mileage be paid at the IRS business rate (currently \$.545/mile).
